This privacy notice discloses the privacy practices for www.crochetbyjennifer.com. This privacy notice applies solely to information collected by this website. This notice has been compiled to better serve those who are concerned with how 'Personally Identifiable Information' (PII) is being used online. PII, as described in U.S. Privacy Law and Information Security, is information that can be used on its own or with other information to identify, contact, or locate a single person, or to identify an individual in context. Please read this privacy notice carefully to gain a clear understanding of how your PII is collected, used, protected, and otherwise handled.

What personal information is collected?

Personal data collected and stored includes the following: Name, business name, email, and various responses to questions regarding crochet ability and preferences. This personal identification information is only collected if user voluntarily submits this information to Crochet by Jennifer (Jennifer Dougherty) through the Pattern Testing Application on www.crochetbyjennifer.com.

How long is personal information stored?

If a pattern testing applicant is not selected to join the Crochet by Jennifer Testing Group, all private information is deleted automatically after 6 months. You can request removal of your private information at any time.

Crochet by Jennifer will use your personal data only for the following purposes:

Crochet by Jennifer (Jennifer Dougherty) collects and uses personal data only as necessary for the purpose for which it was obtained: To select compatible individuals for membership in the Crochet by Jennifer Pattern Testing Group based on the answers provided by the user, and to send emails regarding membership to the Crochet by Jennifer Pattern Testing Group. Your personal data will not be used for any other purpose or shared with any other entity.

How is your information protected?

Your personal information is contained behind a secured network and is only accessible by Crochet by Jennifer (Jennifer Dougherty).

Third-Party Disclosure:

Crochet by Jennifer (Jennifer Dougherty) does not sell, trade or otherwise transfer your PII to any other entity.

Tracking and/or other analytics tools such as Google Analytics:

Crochet by Jennifer does not use tracking and/or other analytics tools such as Google Analytics with your personally submitted information.
